

Health Policy & Planning Internship Program

The San Mateo County Health System is seeking a dedicated and hardworking **Epidemiology Intern** to join the Health Policy and Planning (HPP) team, a program within the Public Health, Policy and Planning Division. The HPP Internship Program is designed to provide work opportunities and practical learning experiences in public health, policy, planning, and research, with an emphasis in health equity and place-based primary prevention.

HPP Framework: Primary Prevention & Health Equity

There is a growing recognition that where we live, work, play, and go to school shape our health. HPP focuses on building healthy, equitable communities that prevent people from getting sick in the first place. HPP works to ensure all people have the opportunity for health and wellbeing and seeks to build health equity by addressing the root causes of poor health, such as the social, economic, and physical conditions around us. To achieve this goal, HPP employs expertise in policy, planning, research, equity, epidemiology, communications, and advocacy. HPP has a particular focus on supporting populations with higher rates of preventable health issues and in places with the fewest opportunities for health.

HPP is currently focused on four areas of work:

- 1) Stable and affordable housing: protects health and provides the ability to engage in healthy opportunities.
- 2) Complete neighborhoods: make it easy for residents to be healthy every day in their own communities.
- 3) High quality education: creates pathways to better health.
- 4) Strong local economy: builds household financial security for all.

Internship Overview: Sociodemographic and Health Impact Analysis

The goal of this project is to understand how the population in San Mateo County has been changing with regards to sociodemographic characteristics and how these trends have impacted health overall. The intern will explore multiple data sources, analyze the datasets, and present findings through maps, charts, and tables. The findings of the project will be used to inform San Mateo County Health System's activities to improve the health status of county residents.

There are multiple data sources the intern will have the opportunity to explore. Data sources may include the Decennial Census and the American Community Survey from the Census Bureau, death

and birth data from the California Department of Public Health, health care use data from the Office of Statewide Health Planning and Development, and the California Health Interview Survey.

Using the previously mentioned data sources, the intern will analyze how sociodemographics and health have changed over time in San Mateo County. Potential variables for analysis include age, sex, race, poverty, income, educational attainment, housing and living conditions, commute and transportation patterns, health outcomes, health behaviors, and health care use. The intern will develop maps, charts, and tables to present the findings.

Specific responsibilities expected of the intern include:

- Conducting literature and internet searches
- Compiling existing data from secondary sources
- Cleaning and analyzing data, both spatial and non-spatial, using Excel, ArcGIS, and/or statistical software
- Developing maps, charts, tables, and other data visualization graphics

The ideal candidate will have:

- Strong skills in data collection, cleaning, management, analysis, reporting, and visualization
- Strong skills in geographic information systems (GIS)
- Strong skills in Excel and statistical software (e.g., SAS, SPSS, R, or Stata)
- Background in Epidemiology, Public Health, Planning, Demography, Geography, or related fields
- Understanding of the intersection between place and health; knowledge of principles of equity and how place impacts health equity
- Knowledge of public health, housing, transportation, public education, economic development, and/or environmental issues
- Familiarity with sociodemographic and/or health datasets, such as the ones previously listed
- Real-world work experience demonstrating the previously mentioned skills and knowledge
- Interest and dedication to advancing health and equity demonstrated through work experience and/or personal experience having been adversely affected by health inequities
- Strong communication and people skills
- Strong organization and time management skills and ability to work independently toward excellent work outcomes

Eligibility

- Current graduate level students and recent graduates up to one year after graduation date are eligible to apply. You may not be a current San Mateo County employee.
- Successful applicants will demonstrate one or more of the following:
 - You, or a member of your family, have been adversely affected by health inequities related to any of the following: a) endured systemic failures of the social, physical, or

- economic environment; b) live or grew up in a low-income neighborhood, c) are the first in your family to attend higher education, or e) have experienced discrimination due to race, ethnicity or other social or economic situations
- Have a deep passion for addressing health inequities, and have experience working in programs that promote equity (this can be through a multitude of intervention types and variety of locations or organizations)

Internship Term & Pay

This HPP Internship program runs June through August. Reasonable timeframe adjustments can be negotiated. **Interns must commit to working a minimum of 32 hours per week for the Summer Internship.** Graduate students are paid \$18.91 per hour.
