THE POSITION:



The Contra Costa County Public Works Department (CCCPWD) is seeking to hire up to four Watershed Management Planning Specialists (WMPS). CCCPWD maintains over 660 miles of roads, 150 miles of streams, channels and other drainage and over 200 County buildings throughout Contra Costa County. CCCPWD provides a wide range of services such as Parks and Recreation, Stormwater Permit Administration, Real Estate, Environmental Permit Review and Flood Control throughout unincorporated areas of Contra Costa County.

The current WMPS vacant positions are located in the Watershed Program and Clean Water Division of the CCCPWD and report to the Senior WMPS. WMPS assist with implementation of the regional storm water permit throughout the County. The focus of the permit work is to prevent pollutants such as litter, micro plastics, oil, pesticides, legacy pollutants, and bacteria from entering nearby waterbodies. WMPS work within and outside the County to collaborate with different agencies to come up with innovative pollution prevention solutions. WMPS provide project management of water quality monitoring, public outreach with citizens and businesses, environmental inspections, meeting facilitation and training of municipal staff, and Green Infrastructure project development.

# **MINIMUM QUALIFICATIONS:**

**License Required:** Possession of a valid California Motor Vehicle Operator's License. Out of State valid motor vehicle operator's license will be accepted during the application process.

Education: Possession of a Bachelor's degree from an accredited college or university with a major in urban or regional planning, engineering, business, geography, chemistry, environmental science or a closely related field.

**Experience:** Three (3) years of full-time or its equivalent professional experience in land use planning, environmental compliance, or other closely related activity.

**Substitution:** A Master's degree from an accredited college or university in urban or regional planning, engineering, business, geography, chemistry, environmental science, or a closely related field may be substituted for one (1) year of the required experience.

#### **SELECTION PROCESS:**

- **1. Application Filing and Evaluation:** Applicants will be required to complete a supplemental questionnaire at the time of application, applications will be evaluated to determine which candidates will move forward in the next phase of the recruitment process.
- 2. Online Performance Assessment: Candidates who possess the minimum qualifications will be invited to participate in an online video interview and writing assessment. The assessment will measure candidates' competencies as they relate to the Watershed Management Planning Specialist classification. These may include, but are not limited to: Critical Thinking, Delivering Results, Displaying Ownership and Accountability, Oral Communication, Political and Organizational Savvy, Project Management, and Innovating Problem Solving.

The Watershed Management Planning Specialist assessment is tentatively scheduled to take place via computer (remotely) on the first week of March, 2021.

The performance assessment will be administered remotely using a computer or mobile device such as a tablet. You will need access to a reliable internet connection to take the assessment, as well as computer or mobile device with a camera. It is not recommended to take the assessment using a cell phone due to the writing component.

The Human Resources Department may change the examination steps noted above in accordance with the Personnel Management Regulations and accepted selection practices.

## **CONVICTION HISTORY**

After you receive a conditional job offer, you will be fingerprinted, and your fingerprints will be sent to the California Department of Justice (DOJ) and the Federal Bureau of Investigation (FBI). The resulting report of your conviction history (if any) will be used to determine whether the nature of your conviction conflicts with the specific duties and responsibilities of the job for which you have received a conditional job offer. If a conflict exists, you will be asked to present any evidence of rehabilitation that may mitigate the conflict, except when federal or state regulations bar employment in specific circumstances.
